#### COURSE-SPECIFIC FEES

Personalised programmes may incur additional fees depending on the level of support required by the student. Any such fees will be discussed with parents during the admissions process.

#### FINANCIAL ASSISTANCE FOR LOCAL FAMILIES

Parents or legal guardians residing in Switzerland who do not receive schooling benefits or tuition reimbursement from an employer/company of more than 50% of the tuition fees, are entitled to a 10% discount on tuition fees.

Families who wish to benefit from this assistance should submit a formal request (form and conditions available from the Admissions Department).

#### SIBLING DISCOUNT

A 5% sibling discount will be applied to tuition fees directly paid by families for any sibling enrolled at Haut-Lac at the same time.

All additional optional activities that are not included in the fixed costs will be billed separately, such as:

Parental consent is required before a student is allowed to participate in optional activities.

The school reserves the right to charge for any additional exam support (including individual supervision costs).

## TAX INFORMATION

Parents may be able to claim a tax deduction for tuition fees depending on their canton of residence and tax status. Local parents, who live in the canton of Vaud, may be able to claim a deduction of up to CHF 9'100 per year (2020) for childcare-related school fee components for children under 14. This relates specifically to lunchtime supervision, out-of-hours care and holiday camps.

As regards expatriate families, total or partial tax deductions are granted according to the company's tax status. We advise parents to approach their employer for more information.

## **PAYMENT TERMS**

Once a student starts attending lessons at Haut-Lac, tuition fees and fixed charges are due for one academic year.

Fixed charges must be paid in one lump sum at the same time as the first tuition fee invoice. No adjustments will be made for midyear enrolments or departures.

Tuition fees must be paid in advance using one of the following payment plans:


#### ANNUALLY

The full year's fees are due on 31 July before the start of the school year.

A **2% discount** is applied to single payments made **before 31 July**. This discount will be revoked in the event of late payment.

#### **BI-ANNUALLY**

Two invoices are issued; the first is due on 31 July (50% of annual fee) and the second on 31 January (50% of annual fee).



Invoices are due on the following dates:

- Term 1 (40% of annual fee) 31 July
- Term 2 (30% of annual fee) 15 December
- Term 3 (30% of annual fee) 15 March

#### MONTHLY

Tuition is billed two months in advance, in 10 equal instalments, from 31 July to 30 April. A **1% surcharge** is applied to the published annual school fees to cover administrative costs.

The default billing option is annually, unless otherwise specified by parents. A change of option must be communicated as soon as possible to <u>billing@haut-lac.ch</u>.

Once an invoice is issued, a change of payment option entails a CHF 50.- surcharge.

# **OPTIONAL COSTS**

## SCHOOL MEALS

Parents may sign their children up for hot meals in the school canteen. The menus are published on the school website, and generally include a soup, main meal and dessert. Primary and Secondary students also have access to a salad buffet every day. Upon enrolment, the children may choose between three high quality local menus (standard, vegetarian or no pork). A glutenfree and lactose free menu are also available on demand.

The published fees take into account occasional absences, ski days, school trips, etc. when this service will not be used. No deductions will be made in the event of absence, except in the case of prolonged absence justified by a medical certificate.

Children who wish to sign up for school meals must do so for either 4 or 5 days each week, and generally for the whole year. Any changes must be submitted to the finance department by e-mail (ursula.ducraux@haut-lac.ch) before the end of one term with effect from the next.

DP2 students are only billed for 50% of the third term's meals, due to their reduced presence at school.

## SCHOOL TRANSPORT

Haut-Lac's school transport system was put in place to meet the demands of the mobility agreement established between the commune of St-Légier and the school. The bus routes and timetables can be found in the Mobility Guide which is regularly updated and published on Haut-Lac's website.

Our buses currently operate on the following routes:

Infant and Primary students may sign up for a maximum of two clubs per week (**included in the fixed fees**) based on availability. Registrations are taken on a termly or annual basis depending on the activity.

Secondary students may take part in clubs (included in the fixed fees) from 15:45 to 16:30, and from 16:45 to 17:30, depending on their interests and timetables.

## CLUBS RUN BY EXTERNAL PROFESSIONALS (15:45 - 16:45)

The prices for clubs run by external professionals are clearly stated in the clubs programme. They vary depending on the activity and are set by the club leader.

Missed sessions are not reimbursed, as occasional absences are accounted for in the published prices.

## AFTER-SCHOOL SUPERVISION

#### INFANT TEDDY CLUB OR PRIMARY SUPERVISED STUDY (15:45 - 16:45)

Children are generally registered for a term at a set fee. Attendance on an ad-hoc basis costs CHF 15 a session.

#### OUT-OF-HOURS SUPERVISION (16:45 - 18:00)





## BOARDING

Haut-Lac works with a local educational partner to provide flexible 5 or 7-day boarding solutions. Our Admissions team can provide families with more information on the different options available to help them make the right decision for their child.

Parents shall enter into separate contractual relationships with each establishment. As regards Haut-Lac, fees must be paid in advance for a full academic year with no discount.

## **PAYMENT TERMS & CONDITIONS**

Bank transfer or standing order are the preferred methods of payment. Credit cards are accepted for payments under CHF 1'000. The school does not accept cheques. No refunds may be claimed for tuition fees and/or fixed charges on account of short periods of absence due to illness, or any other circumstances, for a term already started.

Parents undertake to inform the school immediately of any changes (phone number,

All invoices are payable within 30 days of issue, e-mail, address) in their family and/or child's circumstances.

### LATE PAYMENT

In case of delayed payments a reminder is sent 15 working days after the due date. A CHF 50 surcharge will be levied if a further reminder has to be issued and 5% interest per annum will become payable from the due date. Thereafter, the school reserves the right to embark on debt recovery proceedings and charge the parents for any additional expenses incurred.

All payments due for the current academic year must be settled before the start of the new school year. Otherwise, the school reserves the right to refuse the re-enrolment of a student for the following academic year.

## **WITHDRAWAL**

The school must be notified in writing (to admissions@haut-lac.ch) of any intended withdrawal. A withdrawal notice is not considered valid until acknowledged in writing by the Admissions Department. The departure notice must be signed by both parents or legal guardians.

In the absence of a formal written notification of withdrawal for the end of the current academic year, a student's enrolment is tacitly carried forward from year to year.

Notice of withdrawal must be received before the following dates:

- 15 September for the end of the first academic term
- 15 December for the end of the second academic term
- · 31 March for the end of the school year

# **REVISION & APPLICABLE LAW**

The school reserves the right to change its General Financial Terms and Conditions at any time. The present document supersedes and replaces any previous versions. The school fees are reviewed annually and therefore subject to change from one academic year to the next.

The General Financial Terms and Conditions are considered accepted by parents as soon as they sign the "Enrolment Confirmation/Acceptance Form" or as soon as their child starts to attend classes. The signatories agree to abide by this and subsequent versions of the General Financial Terms and Conditions and associated school fees for as long as their child attends Haut-Lac International Bilingual School.

These deadlines are extended by one calendar month for families whose fees are paid or reimbursed by an employer/company.

Tuition Fees for a term which has been started are payable in full in all cases, even if the student is not present throughout. If the withdrawal deadline is not adhered to, the Tuition Fees for the following term will also become due in full. Cancellation of enrolment less than 30 days before the anticipated starting date makes the parents liable for payment in full of the Tuition Fees for the term in which the student was expected to arrive.

In the event a serious infringement of school rules results in a student being asked to leave Haut-Lac, the obligation to pay the Tuition Fees for the current term in full remains.

Any legal dispute, controversy or claim arising from or relating to these Terms and Conditions and a student's enrolment and schooling at Haut-Lac International Bilingual School, is subject exclusively to Swiss law and the courts with jurisdiction over Vevey.

The English version of the General Financial Terms and Conditions is provided for convenience. Only the French version will be deemed valid in case of dispute.
